4.0 TOURNAMENT REGISTRATION FEES

4.1 CATEGORIES

4.1.1 NOVICE CATEGORIES	RM 200.00 / RM 240.00
4.1.2 35+ DOUBLE	RM 200.00 / RM 240.00
4.1.3 INTERMEDIATE CATEGORIES	RM 220.00 / RM 260.00
4.1.4 OPEN CATEGORIES	RM 250.00 / RM 290.00

Player eligibility is determined based on the DUPR information submitted at the time of registration.

When a participant registers, the registration system records the player's DUPR rating as it appears at that time. If a player's DUPR rating subsequently increases due to participation in other tournaments before this event, it does not affect their eligibility, provided they met the category requirements when they registered.

Players are free to participate in other tournaments after registering, and any resulting DUPR rating changes are part of the normal progression of the rating system. Therefore, eligibility for this tournament will not be reassessed based on rating changes after registration.

This policy is applied consistently to all participants to ensure fairness, transparency, and equal treatment throughout the tournament.

5.0 TOURNAMENT CLOSING DATE

- 5.1 All Entries through form(s) must be complete before
- 5.2 Late Entries without confirmation of payment will not be entertained
- 5.3 **NO REFUND** shall be made after group the draw
- 5.4 Make sure your participation in this tournament had been confirmed by the Organizer before making prior arrangements.

6.0 TOURNAMENT FORMAT

- 6.1.a NOVICE (Men, Women, Mixed) - Non-Finalist DUPR <3.099
- 6.1.b INTERMEDIATE DUPR Combine < 6.599 (Men & Mixed)
- 6.1.c OPEN (Men, Women & Mixed)
- 6.1.d 35+ Double (Any gender combination)

6.2. Player's age shall be based on Years of Birth as stated in Identity Card (IC). All Participating team who under age of **Eighteen (18)** shall submit the **Parent Concern Form** together with the registration form for verification purpose. **(LAST PAGE OF FACT SHEET)**

6.3 Open of **Forty-Eight (48) (Novice Group)** teams divided into Eight (8) Groups. Round Robin with Top Two (2) to the last 16 Teams.

6.4 Open of **Thirty-Two (32) (Intermediate/ 35+)** teams divided into Eight (8) Groups. Round Robin with Top Two (2) to the last 16 Teams.

6.5 Open of **Twenty-Four (24) (Open Group)** teams divided into Six (6) Groups. Round Robin with Top Two (2) to the last 16 Teams. 4 teams giving BYE automatically advanced to top 8.

6.6 **All Group Matches** will be based on Rally scoring format (15). No Deuce. One (1) Set ONLY Per Tie. End change after Score reaches 8.

6.7 **Round of 16 / Quarter Final / Semi Final Matches (Elimination Round)** will be based on Rally scoring format (21). No Deuce. One (1) Set ONLY Per Tie. End change after Score reaches 11.

6.8 **3rd/4th Play-Off Matches** will be based on Rally scoring format (21). No Deuce. One (1) Set ONLY Per Tie. End change after Score reaches 11.

6.9 **Final Matches** will be based on Rally scoring format (21). No Deuce. Best of Three (3) Set Only Per Tie. End Change after one (1) Set. Third (3rd) Set end change after score reaches 11.

6.10 All Group Round Robin Matches must be completed.

6.11 Any Withdrawal during Group Matches. The opponent shall be declared the winner by the score of 8 – 0.

6.12 **A Five (5) Minutes** Walkover will be strictly observed after official announcement.

6.13 No Changes of player are allowed after the Group Stage Draws.

6.14 To ensure observance of sportsmanship conduct during Tie. **“Line Calls”** will be based on **Receiver’s Call**. However, player is allowed to appeal to the referee on duty. Referee call shall be the FINAL.

6.15 The Organizers reserve the right to change the Format/Scoring at the tournament.

6.16 One (1) Minute time out available only from **Elimination Round**.

7.0 Player Eligibility

7.1 DUPR Rating

7.1.1 Players’ DUPR Rating must below the categories require at the time of registration.

7.1.2 Players with DUPR reliability below 30% will be treated as NR.

7.1.3 Players with NR DUPR will treated as 2.50 rating.

7.1.4 NR players may join at the Tournament Director’s discretion. Any cheating (DUPR manipulation, multiple accounts, etc) will result in removal with NO REFUND.

(THE TOURNAMENT COMMITTEE RESERVES THE RIGHTS TO MAKE ALL FINAL DECISIONS.)

7.2 Achievement

7.2.1 Players who ever achieved FINALIST on Mixed Double will not affect on his or her eligibility on the Men or Women Double.

(ONLY RESULTS FROM SANCTIONED / OFFICIALLY TOURNAMENTS WILL BE COUNTED.)

7.2.2 Players who ever achieved FINALIST on Men or Women Double will not affect on his or her eligibility on the Mixed Double.

(ONLY RESULTS FROM SANCTIONED / OFFICIALLY TOURNAMENTS WILL BE COUNTED.)

7.3 Under Aged

7.3.1 Age under 18 and above may participate only with Tournament Director Approval and must submit Parent/Guardian consent letter (last page of the Fact Sheet).

8.0 RULES & REGULATIONS

8.1 USA Pickleball Official Rulebook 2026 will be adopted for the tournament:

8.2 All players must report to the Tournament Desk at least Thirty (30) Minutes before the scheduled match. Players should wait at the “Assigned Court” for your Match Announcement.

8.3 Any player who failed to report for attendance and subsequently missed their first scheduled match of the day will be deemed to have forfeited their spot in the tournament.

8.4 Colour of player’s jersey/apparels must not be Neon Green or Yellow.

8.5 Players must ONLY use USAP-Approved Paddle that is posted in the USAP website (<http://equipment.usapickleball.org/paddle-list/>).

8.6 The organizer reserves the right to rearrange and amend the sequence of match and categories when necessary.

9.0 DISPUTES / COMPLAINTS / RESOLUTIONS

- 9.1 Any Un-honesty registration on category will be Disqualified and RM5,000.00 of compensation will be fine once been detected.
- 9.2 In the interest of the smooth running of the Competition. ONLY the Team Manager are allowed to file any Complaint (s) or Dispute (s) to the Tournament Director (TD)/ Tournament Referee (TR) to be tabled to the Organizing Committee.
- 9.3 A Non-Refundable Deposit of Ringgit Malaysia Two Hundred (RM200.00) is required together with the written Complaint (s) or Dispute (s).
- 9.4 Any decision by the Organizing Committee on any dispute shall be FINAL.

10. OFFICIAL BALL

- 10.1 FRANKLIN X-40 Ball will be the Official Ball used during the Tournament. In case of unforeseen circumstances, the organizers reserve the right to use other brands.

11. INDEMNITY & INSURANCE

- 11.1 This tournament is covered by the sport insurance - ZURICH
- 11.2 However, all the participating teams, and it delegated players/officials Must agree indemnify and hold the Organizers, free and unaccountable for and against any claims arising from personal injury, death or property damage, arising out of or in any way resulting from the participation in the said Tournament or during the travelling to this Tournament.

12. PERSONAL BELONGINGS

- 12.1 It is the player's responsibility to keep their own belongings safe and secure while at the tournament venue. The organizers will not be held liable or responsible for any loss, theft, or damage to your personal belongings.

13. NOTICE OF EVENT POSTPONEMENT & CANCELLATION

- 13.1 In the event that the tournament is suddenly postponed and declared Force Majeure at short notice by the government due to unforeseen circumstances related to natural disasters, riots, outbreak of diseases, fire or any event deemed by government authority as a risk to public interest and safety, the organizers will observe the instruction to postpone or cancel the event without prejudice to any legal action that the participants may wish to take against the organizers e.g. claim for damage, loss, distress etc. under such circumstances the participants agree that they will not hold the Organizers accountable for any form of loss caused to players registered for the tournament.

14 ALCOHOL / DRUGS / TOBACCO

- 14.1 Players registered to compete in this tournament are strictly prohibited from consuming alcohol at PICKLELAB. Indulging in substance abuse, or smoking while participating.
